#### **ABSTRACT**

Dr. Bruce Edwin Brandt, an Emeritus Professor of English at South Dakota State University, has made notable contributions to the field of English Renaissance literature, with a primary focus on Shakespearean studies and Renaissance drama, prose, and poetry. This collection comprises various materials documenting Dr. Brandt's academic and professional endeavors, including committee memberships, syllabi, course outlines, exams, conference participation, research projects, and correspondence. ### **BIOGRAPHICAL NOTE**
